

Accompaniment to Government Resolution, Food, Agriculture and Forests Department No. DDE-1161/3742(II)-Q, dated the 14th March 1963.

Recruitment Rule for the posts of -

- (i) Shift Manager,
- (ii) Dairy Manager, (iii) Assistant Project Officer,
- (iv) Assistant Agricultural Officer, (v) Agricultural Officer, (vi) Technical Assistant, (vii) Dairy Officer, (viii) Senior Dairy Officer (ix) Senior Dairy Development Officer and (x) Manager, Government Dry Stock Farm, Palghar.

Appointment to the posts shall be made either -

(A) by promotion of suitable Officers in the Dairy Development Department possessing the qualifications and experience mentioned in Clause-B (ii) and B (iii) below; or

(B) by nomination from among candidates who -

- (i) unless already in the service of Government of Maharashtra, are not more than 30 years;
- (ii) hold a degree in Dairying, Agriculture (with Animal Husbandry as a subject); Veterinary Science of a recognised University, or a Diploma in Dairying of a recognised Institution;
- (iii) Possess experience of at least three years in a milk supply scheme, a large dairy or an agricultural or dairy farm.

Provided that the age limit will be relaxed in favour of candidates with good qualifications and/or experience.

Provided further that preference will be given to candidates having a post-graduate degree in Dairying of a recognised University or a post-graduate Diploma in Dairying of a recognised Institution.

2. Appointments shall be made by promotion and nomination in the ratio of 1:1
3. Candidates appointed to the posts by nomination shall be on probation for a period of two years.
4. Persons appointed either by promotion or nomination shall be required to pass the Departmental and Language Examinations according to the prescribed rules.
